PROPERTY AND GROUNDS:

- A written report was presented and will be filed with these minutes. There is a long list of ongoing projects which will be prioritized and presented. Sexton reports for January and February were included on that report.
- We would like to let the congregation know that they are part of property and grounds. Needs should be presented to us and help is welcomed.
- We are working on getting registered parking signs.
- We are still negotiating with Sibel regarding paving the parking lot.
- The brick on the church is far overdue to be sealed. We will look into estimates.
- We will be installing a handrail for our ramp.

- The west entrance roof needs to be addressed in the spring.
- The pastor's hallway is being painted. Many areas will be addressed.
- Some landscaping and concrete will need to be addressed on the parsonages.
- Mike Durkin has been working on electric issues. We are considering separating the parsonages from the church.
- There is an existing exhaust system above the church. We are looking into repairing it.
- Lighting is needed behind the church and in the parking lot especially near the garage.

FELLOWSHIP:

- Searching for God through Art part 2 is coming in May.

YOUTH:

- Youth will sell pizza and help with the Meat Raffle.
- Youth are looking to hold a fundraiser for victims of the fires near our church
- There is an upcoming volleyball marathon which should be a lot of fun

- The lock in on Feb 7th was small but fun.
- We had a ½ lock in with West Seneca which lasted until 2am. We learned a lot of new ideas from them. We hope to share lock in events in the future.
- Youth sold loafs of bread for a fundraiser which did very well.

- Sunday school is working with the youth for Palm Sunday

OLD BUSINESS:

- Bequests:
 - Last month spending a portion of the bequests on remodeling the memorial lounge and making a more useful area as a "Legacy" lounge was proposed.
 - Many uses and ideas for this area was discussed.
 - We will be reaching out for ideas and designs for that room.

NEW BUSINESS:
